Where does this role fit in?	<p>The Presidents Advisory Committee provides a mechanism by which the President can obtain information, intelligence and advice, on external developments and contacts, in key areas of interest.</p> <p>Provides a forum for the Vice Presidents and Council Directors to liaise with the President and each other on issues of cross-cutting importance and interest.</p> <p>To agree how and when the Vice Presidents will represent IPEM externally, sharing the ambassadorial and external contributory role of the President.</p>

Examples of work	<ul style="list-style-type: none"> • Advise the President on internal and external issues and policies related to industry practice and activities across the UK via the President’s Advisory Committee • Represent the Institute at appropriate meetings/events, as agreed with the President • Undertake ‘horizon-scanning’ to identify appropriate roles, contacts, partnerships and activities for IPEM in this area • Maintain and develop relationships between IPEM and appropriate companies and industry bodies • Work closely with the managers of the Communities and Commercial teams, advise the National Office re recruitment and support of members from industry settings, and Company Members, suggesting events and other opportunities for engagement. • Maintain and develop relationships between IPEM and appropriate companies • Maintain and develop relationship with Directors of IPEM Science, Research & Innovation Council, Professional & Standards Council, and with the National Office, to bring expertise to the wider Institute.
