Why accessibility matters

Imagine you are going to see a baseball game. The barrier is high, so everyone is given the same box to help them see over it. This works if you're already tall, not so much if you're short.

Everyone is treated equally, but this isn't fair. A fair, or equitable, solution enables everyone to watch the baseball game – providing shorter people with a step as high as they need, so the game is accessible to all three fans.

Imagine now that you're not going to a baseball game, but you're going to a lecture, looking at a poster at a conference, or reading an information leaflet. If you have conditions affecting your vision or perception of language, the way in which the information is presented can pose a significant obstacle to understanding and learning. In order for that information to be accessible to all, care must be taken in how that information is presented. That's the equitable solution.

The need for accessible information online was recognised by <u>new accessibility requirements for public</u> <u>sector bodies</u>, which came into force in the UK on 23 September 2018. These regulations mean that public sector websites and mobile apps will need to be accessible to all users, especially those with disabilities. So new websites published on or after 23 September 2018 will have to be compliant within one year and existing websites within two years. Some organisations and types of content do not need to meet the new standards but hospitals, and further and higher education institutions, are all included within 'public sector bodies'.

These regulations establish in law the expectation that information should be presented in an accessible format, benefiting all readers and widening access to those who would otherwise be excluded. The good news is that creating accessible materials shouldn't create more work or take a great deal of time; by simply making the right design choices you can create resources that are accessible.

This document will guide you through making these changes to your slides, posters, and other materials used in communication with staff, students and patients, so you can reach everyone in your intended audience. The document will cover the following aspects:

Part 1: Making your text documents accessible

Whether it's a report, Powerpoint presentation, poster, or information leaflet, follow these five simple design tips to make your documents accessible.

1. Use styles to identify headings

Using Headings and Styles throughout a document automatically creates a searchable document with easy navigation. Screen readers used by the blind and partially-sighted use these headings to create chaptered sound files, which are much easier to search and edit.

2. Choose an accessible font

Text clarity is important for all users, however if you having a learning difference or disability it is vital to accessing the resource.

When deciding on a font style choose a clear font with space around each character letter with no flicks or tails on the letters. These are easier to read for many people, but particularly those with sight problems.

There are many accessible Sans Serif fonts that can be used, below are a few examples.

- Accessible Font 1,2,3 Calibri
- Accessible Font 1,2,3 Arial
- Accessible Font 1,2,3 Verdana



Here are a few examples of inaccessible Serif fonts, which should be avoided:

3.Use left alignment and bigger spaces between lines of text

Left aligning text reduces eye movements and enables you to read the text easily. It is particularly helpful for those with partial sight, or those who use a keyboard (rather than a keyboard & mouse) to navigate the text.

1.5 spacing or higher increases the space around text making it much easier for those with sight problems to view. Breaking up dense blocks of text in this way can also make information less overwhelming and easier to read for those with learning differences affecting reading and writing, such as dyslexia.

4. Use accessible ways of highlighting text

5. Choose accessible background and font colours

The choice of background and font colour can have a marked effect on how clearly text can be seen. The columns below show some examples of background colour and font colour combinations.

Column A shows poor contrast between the background and font colours. This makes the text difficult to read. Some of the colours chosen clash, creating an uncomfortable viewing experience for all viewers. It is also worth noting that 1 in 100 men and 1 in 300 women are red/green colour blind, meaning that many people cannot read red and green together. Colours to avoid, particularly together are red, green and often yellow.



Column B shows good contrast between dark text and the light background. This combination supports the widest group of users. It is easy on the eye, and clear to read for those with a learning difference affecting sensory processing (such as dyslexia or autism). Note that a pale colour is chosen rather than white, as the stark contrast between black and white can be perceived as harsh and strain the eyes.

Column C shows good contrast between light text on a dark background. This is accessible and most legible for those with a sight impairment. It is often used in banners to grab attention but some users can find it overwhelming when reading larger amounts of text, and much prefer the pastel background. You may want to consider using these combinations of light text on a dark background sparingly, depending on your intended audience.

This document

This document has been checked by the built-in accessibility checker of Microsoft Word (newer versions) and should be fully accessible. It probably looks a bit different to what you might normally produce but it gives an example of good practice.

Part 2: Making your data accessible

Once you have applied accessible formatting to the text of your document, it's time to add some illustrative figures. Whether it's a table or a chart, follow these simple formatting tips to clearly present your data to the widest possible audience.

1. How to make tables accessible

Present the data in the most obvious, clear arrangement you can, to help all users navigate your tables successfully. Use the simplest table layout possible, and keep the layout regular, avoiding merging cells or leaving empty cells.

In addition, be careful in identifying a heading row. Emboldening or colouring text is a common way of identifying heading rows, but this does not identify text as a heading to screen readers. If you do not formally identify headings, users who rely on this assistive technology will hear a long stream of data, mixed into the order which may well differ to that desired by the creator, and difficult to understand.

An example of an inaccessible way to list data is shown below:

To designate a **Header Row** ensure the corresponding check box is ticked in **Table Tools**, **Design Tab.** There are also options for a Total Row and First Column Row. Each option communicates the location of the Headers. An example is shown below:

A screen reader can now read the table in a variety of ways depending on the user settings as the headings have been identified.

It is also helpful to those using screen readers to include a general description of the chart, to aid navigation. This is how you do it:

- 1. Right click the table
- 2. Select Table Properties
- Select Alt Text

2.Creating Accessible Charts

Many charts rely heavily on colour to identify different data categories. Colours can be perceived very differently by many people and so it is wise not to rely on colour alone to differentiate between data categories. Make sure you do not identify elements by colour alone, but always label with accessible text as well. If you use colour, consider using the same colour with differing shades to enable identification on the basis of the intensity of colour rather than the particular shade. Consider using a pattern fill instead, to identify the different elements for easy black and white viewing.

Below are some examples of how to do it... and how not to!



Accessible Bar Chart Examples: The data is clear and the displayed in a way that colour is not the only way to distinguish between the categories





Accessible Line Chart Examples: Using different line styles means that you can easily distinguish between the data sets without relying on colour.



Inaccessible Chart Examples: It is difficult to distinguish between segments and lines unless you have the same perception of these colours as the creator of the chart. The text is not close enough to the segments and lines to help identify which is which.







It is also helpful to those using screen readers to include a general description of the chart, to aid navigation. As an example, this is how you do for a chart in Excel :

- 1. Right click the chart
- 2. Select Format Chart Area
- 3. Select Alt Text

The careful choice of colours, use of formal table headers and alt text are small modifications that are not particularly time consuming, but can make all the difference between whether your data can be understood, or not. These are good habits to get into, even if you are not expecting anyone with a sight problem to access your documents.

Part 3: Making multimedia accessible

Using sound and video can greatly enhance the presentation of information, and it is now commonplace to add video clips to teaching presentations in particular to illustrate the concepts described and provide material for discussion. However, as with all resources, consideration needs to be given to those who are potentially unable to access the content. Below are just a few things you should consider to improve the experience for all users and reach a larger audience.



1.Considering those with hearing impairments

People who are unable to hear audio included in recorded lectures or podcasts require a transcript of the spoken sound. A transcript enables a deaf user to access the audio content, and may be used whilst watching the video. **Transcripts** are either text or braille, and include the verbatim dialogue along with additional details which help communicate what is being said more fully, e.g. laughter, crying. For video content, closed **captions** are needed provide a more complete full description of what is included in the audio, including both dialogue and other pertinent details, e.g. laughter, door closing. **Subtitles** are used when the dialogue is needed. If the dialogue stands alone without mention of any additional or background sounds, using only subtitles may be suitable. However, if these incidental sounds will affect how the dialogue is perceived, then closed captions will be needed.

The three main criteria that need to be considered for **captions** and **subtitles** are:

- 1. Synchronized captions and subtitles must be available at the same time as the video and audio, so the information from the multimedia is received in the same way by all members of the audience.
- Accessible captions must be accessible with good colour contrast, font and background, which makes it easy to read the text.
- 3. Textual equivalent– captions must present the same content that is available from the multimedia format, so that the same message is communicated with and without sound.

There are a variety of captioning and subtitling services available to help you add these features to video. Some examples are listed below:

How To Add Closed Captions And Subtitles To Your YouTube Videos

Free Video Captioning Tools:

<u>Amara: Caption, Subtitle and Translate Video</u> <u>Dotsub: Caption and translate videos online</u> As the leading video streaming site, <u>YouTube provides a free subtitle and captioning service</u>.

If you use Microsoft or Apple platforms there are also services available within their suite of products:

- Microsoft PowerPoint O365 now includes speech to text live subtitling and recording feature
- Microsoft Stream includes the ability to add captions and subtitles to uploaded videos
- Apple Subtitles and Voiceover features are also available



2. Considering those with visual impairments

People who are unable to view video require the visual experience to be carefully scripted in a way that ensures all important content is accessible through audio. A narration sound file can be provided to support the content if information is displayed in a visual format only.

Audio description can also be included in the media file, as used in this YouTube Lion King example clip.





A variety of tools are available for creating audio descriptions, here are two free options you may wish to try:



<u>Audacity is a free open source tool</u> for creating sound files and can be used to create a narration file and uploaded to streaming services such as YouTube.



<u>YouDescribe – audio description for YouTube Videos</u> is a free accessibility tool to add audio description to YouTube videos. It allows anyone, anywhere to contribute description of an existing video and let a viewer who is visually impaired check it out right away.



3. Considering those with motor skills impairments

Teaching materials are typically made available to the audience after the lecture or tutorial, so that attendees can review and revise what has been presented. In this scenario, care needs to be taken to ensure the presentation remains accessible to those with motor-skills impairments which mean they are unable to use a mouse, as they who would otherwise have difficulty in navigating the presentation.

People who are unable to use a mouse require a multimedia player that:

- works with a keyboard alone
- responds to verbal commands using speech input
- is not set to auto play on display

The first full accessible video player is called <u>OzPlayer</u>, and is free for not-for-profit use. For a full list of accessible players and specifications, visit the <u>Digital Accessibility Matters Website</u>.

Whilst these steps are specifically designed to make presentations accessible to those with hearing, sight and motor skills impairments they can be useful to other users in a variety of situations. For example, transcripts enhance multimedia experiences for those who are unable to listen to sound in a particular social context, have defective computer audio, or are unfamiliar with technical jargon and need to view what is being said alongside a dictionary or translation software.

Part 4: Assistive technology and apps

Assistive Technologies are tools, including software, which enable a user to access a resource which otherwise would be inaccessible.

For example a user who is partially sighted may struggle to view all aspects of a digital document however by utilising a Screen Reader they can listen to all the information included in the document, removing the barrier of inaccessibility.

If the previous tips listed in the blog series are applied to your resources, a user of assistive technologies will generally be able to interact with your materials.

1. Types of specialist assistive technology software

- **Text to Speech Readers** are designed to support sighted users with Specific Learning Differences (SpLD) for example Dyslexia or Dyspraxia The user can listen to text in documents or webpages by hovering over or selecting text with the mouse or keyboard.
- Screen Readers are designed for partially sighted or blind users. The software reads all elements of the page and includes all functionality via keyboard shortcuts. The access is often referred to as a Non Visual Desktop Access (NVDA).
- **Magnifiers** enable the screen to be enlarged in a variety of ways and the text reflowed to reduce the need for horizontal scrolling. The software also changes the contrast and colour of the page to maximise access to the resource.
- Mind Mapping software supports those with organisational, time management and sequencing difficulties enabling thoughts and learning to be communicated in an understandable manner which is easy follow. This software is often used by those with specific learning differences such as Autism, Dyslexia or Dyspraxia.
- Screen Overlay and Ruler software covers the screen area with a coloured transparent overlay of the user's choice, improving the reading experience for all items displayed. The screen can also be masked to isolate the areas being read or underlined like a ruler. This is useful for those with specific learning differences, particularly Autism, Dyslexia, or Dyspraxia, or partially-sighted users to focus on the area of focus and ease reading.
- **Dictation** software enables the user to speak and the computer type the spoken words, this tool can support a wealth of users including those with motor skills impairments.



The table below gives an indication of how assistive tools (AT) can be used to support specific user needs:

2. Free Assistive Tools

Assistive software can be expensive to purchase, however there are now many free software tools, browser extensions and apps which provide effective support to a wide range of users.

<u>AT Bar</u> is free and allows you to change the look and feel of webpages, increase and decrease font sizes, have text read aloud, use coloured overlays, readability and a dictionary to aid reading. Spell check forms and try word prediction when writing. It is a simple tool which is available for most popular browsers



<u>My Computer My Way</u> is a website which shows you how to alter your device to best support your user needs.

3.Browser extensions

Extensions are small software programs that customize the browsing experience by adding an icon to your website toolbar which can be toggled on or off. They enable users to tailor functionality and behaviour to meet individual needs or preferences on the Internet.



Google Chrome has a full suite of extensions available via their <u>Chrome Web store</u> however you will need a free Gmail account. Other browsers are increasing their use of extensions however the list below are all sourced from the Chrome Web Store.

4.Apps

'App' is short for application, which are small programs downloaded to smart phones and tablets. Apps can change the way you interact with your device and provide a wealth of accessibility support. Apps are downloaded from online stores, which one depends on the brand or type of your device. For example:

- Apple products access the App Store
- Android products access Google Play Store
- Windows products access Windows Marketplace

Some Apps are free, others are low cost, but some can be considerable more expensive, so ensure you check the price before you download.
